




Fiscal Year 2000 Performance Partnership Agreement




Utah Drinking Water Program Compliancance/Enforcement Policy





Solid and Hazardous Waste Program





Grants Policy Issuance (GPI) 08-05: Burden Reduction for State Grants

Purpose

This policy codifies and summarizes actions taken by EPA to address major grant-related issues identified under the Agency's State Reporting Burden Reduction Initiative. These actions cover State grant awards, as described below, in the following areas:

- A.** Bundling of Assurances/Certifications
- B.** Financial Status Reports
- C.** Grant Workplan Progress Reports Submitted under 40 C.F.R. § 31.40
- D.** Cost Reviews

Effective Date

This policy will be effective for all new awards made on and after October 1, 2008.

A. Bundling of Assurances/Certifications

As authorized by GPI-08-01, Regional Grants Management Offices (GMOs) may receive and maintain "bundled" assurances/certifications for Regionally awarded grants to State agencies under 40 C.F.R. Part 35.

B. Financial Status Reports (FSRs)

For State grants awarded under 40 C.F.R. Part 35 Subpart A, FSRs will be submitted no more frequently than annually, unless a recipient is considered "high risk" under 40 C.F.R. § 31.12.

C. Grant Workplan Progress Reports Submitted under 40 C.F.R. § 31.40

1. Attachment 1 lists general frequencies, applicable to selected State grant programs, for formal grant workplan progress reports submitted under 40 C.F.R. § 31.40 (§ 31.40 workplan progress reports). Regions and National Program Managers may require more frequent § 31.40 workplan progress reports (not to exceed quarterly reporting) only: 1) where agreed to by a State and documented in the grant award terms and conditions; or 2) where there are performance issues, including Agency concerns with the timely and appropriate expenditure of funds by the recipient. The Office of Grants and Debarment (OGD) may periodically revise Attachment 1 to add general § 31.40 workplan progress report frequencies for other State grant programs after consultation with National Program Managers, Regions and the States.

This policy applies to the frequency of §31.40 workplan progress reports; it does not affect other State reporting to EPA such as reporting to Agency data systems or reporting required by National Program Guidance or by statute or regulation. Nothing in this policy limits the ability of Regions and States to negotiate different frequencies (no more frequent than quarterly and no

less frequent than annually) for § 31.40 workplan progress reports as part of the joint evaluation process under 40 C.F.R. § 35.115.

2. A number of the grants listed in Attachment 1 may be combined into Performance Partnership Grants (PPGs). For grants that are included in a PPG, unless otherwise agreed to by a State and subject to the conditions in Section C.1: 1) the Agency will require semi-annual § 31.40 workplan progress reports only for those Attachment 1 programs approved for semi-annual reporting; and 2) annual § 31.40 workplan progress reporting will be required for all programs included in the PPG.

3. The EPA Project Officer or designated technical representative will be the Agency's single point of contact for receiving § 31.40 workplan progress reports for State grants awarded under 40 C.F.R. Part 35 Subpart A.

4. On August 18, 2008, OGD approved a class deviation from 40 C.F.R. § 35.6650. Under the terms of the class deviation, State recipients of cooperative agreements under 40 C.F.R. Part 35 Subpart O will have 60 days from the end of each reporting period to submit interim progress reports.

5. On July 8, 2008, the Agency received a request from the Association of State and Territorial Solid Waste Management Agencies (ASTSWMO), on behalf of the 50 States, the District of Columbia and the Territories of the U.S. Virgin Islands, Puerto Rico, Guam, American Samoa, and the Northern Mariana Islands, regarding grants under Section 128(a) of the Comprehensive Environmental Response, Compensation and Liability Act. Specifically, ASTSWMO asked the Agency to ease the reporting burden on States receiving Section 128(a) funding by extending a semi-annual reporting requirement to 60 days rather than the current 30 days. Consistent with the flexibility provided by 40 C.F.R. § 31.40, EPA will allow Section 128(a) State recipients to submit semiannual progress 60 days after the reporting period.

D. Cost Reviews

In March 2007, OGD issued interim, streamlined cost review procedures for State grants awarded under 40 C.F.R. Part 35, Subpart A. These procedures applied to State applicants that submitted an adequate internal controls assurance concerning their personnel and travel management systems and were not deemed high-risk. GPI-08-04, issued on September 30, 2008, contains final cost review procedures, which take into account feedback on the interim policy from EPA offices and the States.

E. Review and Evaluation

In consultation with the State Grants Subgroup, OGD will review this policy periodically to ensure its effectiveness and make any necessary revisions.

G. Waivers

In response to a written request from the appropriate Senior Resource Official, the OGD Director may approve waivers to this guidance on an individual or class basis because of national security concerns, circumstances of unusual or compelling urgency, unique programmatic considerations, or because the waiver would be in the public interest.

H. Roles and Responsibilities

For covered awards, Program Offices and Grants Management Offices must ensure that the provisions of this guidance are followed, as appropriate, in the review of grant applications, in the development of grant terms and conditions and during grant oversight.

ATTACHMENT 1

This Attachment lists general frequencies for the submission of 40 C.F.R. § 31.40 grant workplan progress reports covering selected State grant programs. As noted in Section C. 1. of the GPI, for individual grants awarded under these programs, Regions may require more frequent § 31.40 workplan progress reports (not to exceed quarterly reporting) only where agreed to by a State or where there are performance issues, including Agency concerns with the timely and appropriate expenditure of funds.
