PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO SOLICIT PUBLIC COMMENT REGARDING SPRINGVILLE'S INTENTION TO MODIFY ITS PRETREATMENT REGULATIONS REGARDING ITS SEWER ORDINANCE. THE SEWER ORDINANCE HAS BEEN REVIEWED BY THE DIVISION OF WATER QUALITY, ONCE THE PUBLIC NOTICE AND COMMENT PROCESS ARE COMPLETED; IT IS THE DIVISION OF WATER QUALITY'S INTENTION TO FORMALLY APPROVE THE MODIFICATIONS TO SPRINGVILLE'S SEWER ORDINANCE.

BACKGROUND

Springville City has modified its sewer ordinance. The changes could impact industrial dischargers discharging to the Springville City publicly owned treatment works.

PUBLIC COMMENTS

A public hearing can be requested but must be filed during the 30 day comment period which will end on May 23, 2014. A request for a public hearing must be filed per the requirement of 40 CFR 403.11. After considering public comments the Utah Water Quality Board may approve the sewer ordinance, revise it, or abandon it. The Utah Water Quality Board will not publish a notice of decision provided: Springville's ordinance will be approved without any changes to the ordinance and no comments are received during the public comment period.
