CORRECTIVE MEASURES IMPLEMENTATION WORK PLAN AND REPORT
SOLID WASTE MANAGEMENT UNIT (SWMU) 13
TOOELE ARMY DEPOT SOUTH (TEADS) AREA

The Director of the Division of Waste Management and Radiation Control invites comments from the public regarding a plan for cleanup of diesel fuel contamination in groundwater at SWMU 13 at TEADS. TEADS has proposed use of interceptor trenches to remove fuel from the shallow subsurface and monitored natural attenuation to remove contamination dissolved in the groundwater. The main water bearing aquifer has not been impacted by this release.

The public comment period to receive comments on the no further action proposal will commence on July 26, 2016 and end on August 24, 2016.
